Premise

Legislative Decree no. 82 of 27 May 2022 transposed Directive (EU) 2019/882 of the European Parliament and of the Council of 17 April 2019 on accessibility requirements for products and services.

Guidelines on the accessibility of services, in implementation of art. 21 of Legislative Decree no. 82/2022.

The decree was published in the Official Gazette (General Series no. 152 of 01-07-2022) and entered into force on 16 July 2022, but the relevant provisions are effective from 28 June 2025.

Requirement compatibility status

The https://www.zeusiba.it/ website is partially compliant with the requirements of Annex A of UNI EN 301549:2018 (WCAG 2.1) due to the cases of non-compliance and/or exceptions listed below. Zeus Iba S.r.l. is conducting, together with its suppliers, an analysis aimed at making the necessary interventions to make the sites in question accessible and compliant with the standard.

Inaccessible content

The following content is not accessible because it is not compatible with the underlying harmonised standard EN 301 549:

- •On a page there is a link without link text. | WCAG: 4.1.2
- •On individual pages, the contrast between text and background is too low. | WCAG: 1.4.3
- •There are titles on individual pages that do not have a caption or contain the air-hidden attribute and are therefore not accessible to screen readers. | WCAG: 1.3.1
- •There are invalid air attribute values on a page. These are not recognized by screen readers and therefore do not display correctly. | WCAG: 4.1.2
- •On a page, a parent element lacks the appropriate child elements. This can be confusing for screen reader users, as they expect content that isn't there. | WCAG: 1.3.1
- •On almost all pages, there are particularly important areas that are marked with the role 'region' but have no labeling at all. This means that screen reader users cannot recognize the purpose and content of the area. | WCAG: 1.3.1
- •There are interactive elements on individual pages whose names are not part of the labeling. This makes it difficult to control the website using voice control. | WCAG: 2.5.3

Evolutions made to the code and future ones have been and will be developed in accordance with WCAG 2.2 guidelines. The declaration was drawn up on **30.06.2025**. It was carried out using an assessment that complies with the requirements of Directive (EU) 2019/882 through a self-assessment carried out directly by the supplier.
